Melissa was the Director of the Private International & Commercial Law Section of the Attorney-General's Department. This Section is the National Organ to the HCCH and the Central Authority for the 1965 Service and 1970 Evidence Conventions.

In 2023, in partnership with the amazing people at Paradigm, Inc., now @Gov and Apostille Xpress, Montana began a pilot program that has led to the issuance of over 750 e-Apostilles to more than 55 different countries. She serves on the Executive Board of the Notary Public Administrator's Section of the National Association of Secretaries of State and in 2021 she was the recipient of the National Notary Association's March Fong Eu award, given to an individual who seeks to improve the standards, professionalism, and effectiveness of the Notary Public office in the United States.
