

TABLES ON THE COSTS ASSOCIATED WITH INTERCOUNTRY ADOPTION

The *Tables on costs*¹ are designed to increase transparency by compiling the available information on the costs of intercountry adoption in States of origin and receiving States.

The Tables do not aim to provide prospective adoptive parents ("PAPs") or other actors with a definitive, "total cost" for an intercountry adoption. Rather, they aim to be a reference point for PAPs and other actors to identify if the costs which they encounter in the State of origin (Table I) and the receiving State (Table II) are of the nature and within the range provided in the Tables. The Experts' Group will continue its discussions regarding the best method of collecting the data as well as the timeline for providing the data. It will also decide on where and how the tables should be published.

The Tables also include information about the "contributions"² which may be demanded from PAPs by certain States of origin or adoption accredited bodies in the context of an intercountry adoption. Such contributions should not be considered as "costs" of an intercountry adoption since they are distinct from the real or actual costs of the adoption procedure (*i.e.*, they are distinct from the cost of providing all the services necessary in the receiving State and the State of origin to complete each particular adoption). Nevertheless, in order to reflect the current practice of some States,³ they have been included in the tables.

INSTRUCTIONS FOR COMPLETION OF THE TABLES

Tables I and II may be completed by States to provide information concerning the estimated costs and contributions associated with an intercountry adoption in the particular State of origin or receiving State.

States of origin may complete Table I. Receiving States may complete Table II. States that are both States of origin *and* receiving States may complete both Tables.

Column "Purpose"

The "other" category should be used to add any category of costs not previously listed in the column. Please be as specific as possible.

Column "Charged by"

For each category of costs, please select the type of authority, body or person that best corresponds.

According to Vietnamese Law, prospective adoptive parent(s) has/have to personally travel to Vietnam for entrustment without compulsory minimum number of days staying in Vietnam (normally from 2 to 4 weeks).

(*) In comparison with the Table in 2023, several figures have been changed because of the change of exchange rate and increase in service fee. Administrative application fee (intercountry adoption registration fee) and administrative processing fee, as stipulated by law, remain 9,000,000 VND and 50,000,000 VND respectively;

- Administrative application fee is reduced 50% for intra-family adoptions or for the second child in adoptions where two or more children are siblings.

(**) 95% of the expense (2,158 USD) will be sent to provincial level budgets in order to upgrade/improve quality of child care service/child protection system in local, in which:

- + 70% is used to nurture, care for, educate children and improve conditions of infrastructure, equipment serving children's demand and benefits;
- + 15% is supplemented to salary budget to upgrade professional skills of institutions' staffs;
- + 5% is used to verify background of children to be adopted;
- + 5% is used to complete procedures and entrustment of children;
- 5% is used to collect and transfer expenses; acknowledge receipt to the payers; compile books to supervise, control the use of these expenses for assuring its right purpose and effective usage; collect and classify to synthesize and report publicly yearly about collecting, handing in, using expenses for processing domestic adoption in the whole country under provisions and suitable to international routine.

(***) - Health examination for a child (general check-up): 150 - 200 USD/case.

- Specialized medical examination (ultrasound, Xray, MRI, blood test, HIV test, audio-visual evoked potential ...): 150-250 USD/case.

¹² States should be aware of the psychological trauma to the child which could occur when several trips are made to meet the child before he or she is finally entrusted to the adoptive parents.

- Treatment and improvement child's health: 500 – 2000 USD/case. In some special cases the amount can be up to 3000 USD (for heart/brain surgery, autism treatment...), or even 10,000 USD (for a child with life-threatening illnesses);
- Re-examination after treatment: 270 – 320 USD/case.
- Travel fares and accommodation expenses for staffs of institutions who help take children to the hospitals (from remote/mountainous areas to big cities): 120 – 500 USD/case.

- Psychologists/counselling: for an older child and/or a child with psychological problems: 300 –1000 USD/case.
