### **MARA GABRILLI**



Senator for the State of São Paulo (2019–2026), representing the Social Democratic Party (PSD).

Member of several Standing Committees at the Federal Senate of Brazil and rapporteur to the Joint Permanent Committee on International Migration and Refugees (*Comissão Mista Permanente sobre Migrações Internacionais e Refugiados – CMMIR*)

Formerly, was a Member of the United Nations Committee on the Rights of Persons with Disabilities (2019–2022), being the first Brazilian elected to the position.

Founder of the Mara Gabrilli Institute, a non-profit organization that promotes scientific research on paralysis treatment and social inclusion for persons with disabilities. Recognized for her legislative work on the Brazilian Law on the Inclusion of Persons with Disabilities and her long-standing advocacy for human rights and accessibility.

# **ELMANO DE FREITAS**



Governor of the State of Ceará, Brazil, since January 2023.

Holds a Law degree from the Federal University of Ceará (UFC). Before taking office, served as State Deputy and as Secretary of Education and Coordinator of the Participatory Budget of Fortaleza.

Has dedicated his career to promoting social development, education, and public participation, with a long-standing commitment to defending the rights of workers and vulnerable communities.

# ENRIQUE RICARDO LEWANDOWSKI



Minister of Justice and Public Security of Brazil.

Former Justice and President of the Federal Supreme Court (STF), of the Superior Electoral Court (TSE), and of the National Council of Justice (CNJ).

Holds a PhD in Public Law from the University of São Paulo (USP), a master's degree in law from the same institution, and a Master of Arts in International Relations from The Fletcher School of Law and Diplomacy (Tufts University/Harvard University).

Professor of General Theory of the State at the Faculty of Law of USP, where he has taught since 1978. He chaired the Department of Public Law and coordinated the Master's program in Human Rights.

Recognized for his scholarship in constitutional law, human rights, and federalism.

# JORGE RODRIGO ARAÚJO MESSIAS



Minister of the Attorney-General's Office of Brazil since January 2023.

Graduated in Law from the Faculdade de Direito do Recife (UFPE, 2003), Master in Development, Society and International Cooperation (UNB, 2018), and PhD in Law (UNB, 2024).

National Treasury Attorney since 2007 and member of the Attorney-General's Office, with prior roles as Deputy Chief for Legal Affairs at the Presidency of the Republic, Secretary of Regulation and Supervision of Higher Education at the Ministry of Education, and Legal Advisor to the Ministries of Education and Science, Technology and Innovation.

## **ESTELIZABEL BEZERRA**



Human rights advocate and currently serving as National Secretary for Combating Violence Against Women (SENEV) at the Ministry of Women, Brazil. Graduated in Journalism from the Federal University of Paraíba (UFPB).

Formerly, was Secretary of Planning, Secretary of Transparency, and Coordinator of the Democratic Budget for the city of João Pessoa. Also, was State Secretary of Institutional Communication and Chief of Staff of the Government of Paraíba. Also served for 15 years in the feminist collective Cunhã.

Elected twice as State Deputy (2014–2018), authoring legislation on social protection and citizenship. Also presided over several standing committee of the Chamber of Deputies, including the Committee on Defense of Women's Rights, and leading parliamentary fronts on Political Reform, Environment, LGBT Rights, and Diversity and Democracy.

# MARIA DA PENHA



Founder and President of the Maria da Penha Institute, a non-profit organization dedicated to combating domestic and gender-based violence and promoting women's rights in Brazil. Pharmacist and biochemist, with a Master's degree in Parasitology and Clinical Analysis from the University of São Paulo (USP).

Her fight for justice after surviving an attempted femicide in 1983 led to the landmark case Maria da Penha v. Brazil, before the Inter-American Commission on Human Rights, resulting in the enactment of the Maria da Penha Law (Law No. 11.340/2006), which strengthened protections for women against domestic and family violence in the country. Internationally recognized for her advocacy in promoting gender equality, human rights, and accessibility for people with disabilities. Recipient of the International Women of Courage Award (United States, 2010), the Grand Cross of the Order of Isabella the Catholic (Spain), and the Brazilian Government's Human Rights Award (2013).

### **REEM ELSALEM**



Ms. Reem Alsalem (Jordan) is the United Nations Special Rapporteur on violence against women and girls, its causes and consequences, since August 2021. She holds a Masters in International Relations from the American University in Cairo, Egypt (2001) and a Masters in Human Rights Law from the University of Oxford, United Kingdom of Great Britain and Northern Ireland (2003). She is an independent consultant on gender issues, the rights of refugees and migrants, transitional justice and humanitarian response.

### CHRISTOPHE BERNASCONI



Dr Christophe Bernasconi took the office of Secretary General of the Hague Conference on Private International Law (HCCH) on 1 July 2013. In 2018, he was reappointed for a further term of five years; and in 2023, he was appointed for another five-year term (effective 1 July). Dr Bernasconi had joined the Permanent Bureau (the Secretariat of the HCCH) in September 1997 as Secretary, became First Secretary in May 2000, and Deputy Secretary General in July 2011.

He holds a law degree from Fribourg University in Switzerland (*magna cum laude*; bilingual German and French), an LL.M. degree in comparative law from McGill University in Montreal (Canada) (concentration on International Commercial Law, with a Master's Thesis on oligopolies in unfair competition law), and a doctoral degree (*Dr. iur. utr.*) in Private International Law from Fribourg University (*summa cum laude*). He has been actively involved in numerous normative projects and non-normative activities of the HCCH, covering the full range of its mandate, from transnational litigation and Apostille (incl. the e-APP), to international family and child protection law, as well as commercial, digital and finance law. As Secretary General, he is focusing on the good governance and strategic development of the HCCH, spearheading efforts towards its universality and inclusiveness.

Before joining the Permanent Bureau, Dr Bernasconi lectured Private International Law at the University of Fribourg, worked as Legal Expert at the Swiss Institute of Comparative Law in Lausanne, and as Scientific Collaborator at the Federal Office of Justice in Switzerland. He also advised practitioners on various Private International Law matters.

# **SESSION 1**

### MARTINA ERB-KLÜNEMANN



Martina Erb-Klünemann is a German family court judge. She worked as a judge in civil law and criminal law cases at various courts before her appointment as a family judge in 1996. In this capacity she is responsible for international family conflicts pending at Hamm District Court as the centralized court for the District of Hamm Court of Appeals. Over the years, she has dealt with more than three hundred cases on return under the 1980 Hague Convention as a judge.

Since 2009 Martina Erb-Klünemann is a network judge in the International Hague Network of Judges and in the European Judicial Network in civil and commercial matters.

She publishes and runs worldwide training courses on cross-border family law and mediation in cross-border family conflicts.

Her main focus is on return proceedings under the 1980 Hague Convention and on strengthening children's rights in cross-border proceedings.

For many years, she has chaired the annual meetings of German judges who handle return proceedings. She has trained judges and employees of Central Authorities in various European and non-European countries in the application of the 1980 Hague Convention and advised ministries on the development of effective implementing legislation.

### ADRIENNE BARNETT



Dr Adrienne Barnett is a Reader in Law at Brunel University of London. Dr Barnett practised as a barrister for over 30 years, for 25 of which she specialised in Family Law, before moving into full time academia in January 2014. Her specialist area of research for the past 28 years has been domestic abuse and family court proceedings, including Hague Convention abduction proceedings, and, more recently, parental alienation and domestic abuse. She is a member of the Advisory Group of Rights of Women, the UK lead on the International Strategy Group of Hague Mothers and a Co-Director of Right to Equality. Her wide range of publications include a literature review for the Ministry of Justice to support the 'Harm Panel' inquiry, published in June 2020. She is currently undertaking a study of domestic abuse and parental alienation in family court proceedings funded by the BA/Leverhulme Small Projects Scheme, and an analytical study of recent England and Wales Hague Convention judgments funded by Brunel's Institute of Communities and Society.

YUKO NISHITANI



Yuko NISHITANI is Professor of International Private and Business Law at Kyoto University in Japan and Vice-President of the Hague Academy of International Law. She specializes in Private International Law (Conflict of Laws), Cross-Border Dispute Resolution, International Business Law, Comparative Law, and Family Law.

After graduating from Kyoto University in Japan, she did a Ph.D. in Heidelberg and researched abroad for ten years. She held visiting professorships at NYU and Duke in the U.S., as well as in Belgium, Switzerland, Italy, Israel, and Taiwan. She has served on several Legislative Committees in Japan and been a delegate of Japan at the HCCH. She was awarded the Philipp Franz von Siebold Prize by the Federal President of Germany (2020). Nishitani is fluent and publishes in Japanese, English, German, and French. Her areas of interest encompass global legal pluralism, colonialism, cultural identity, SDGs, business and human rights, climate change, and transnational dispute resolution. Her monographs include: (1) Mancini und die Parteiautonomie im Internationalen Privatrecht (2000), 536 pages; (2) Identité culturelle en droit international privé de la famille, in: Recueil des cours, Vol. 401 (2019), pp. 127-450; (3) Japanese Private International Law (with Kazuaki Nishioka) (2021), 320 pages.

MERLE WEINER



Merle Weiner is the Philip H. Knight Professor of Law at the University of Oregon School of Law. She is a graduate of Dartmouth College (B.A.), Harvard Law School (J.D.), and Cambridge University (LL.M.).

Professor Weiner's teaching and scholarship have addressed domestic and sexual violence for approximately twenty-five years. She is the founder of the University of Oregon's Domestic Violence Clinic, a program that provides legal services to low-income survivors of domestic violence, sexual abuse, and stalking.

Professor Weiner has written extensively about the Hague Convention on the Civil Aspects of International Child Abduction and how it affects domestic violence victims who are fleeing transnationally for safety. Her work has been cited by the United States Court of Appeals for the First, Second, Sixth, Seventh, and Eleventh Circuits. She has trained judges, lawyers and law professors on the topic, including through the auspices of the National Criminal Justice Training Center, the National Association of Women Judges, the ABA Commission on Domestic and Sexual Violence, the National Council of Juvenile and Family Court Judges, the Practicing Law Institute, and the Association of American Law Schools. In addition, she has advised domestic violence organizations filing amicus briefs in Hague Abduction Convention cases (including four out of five cases before the U.S. Supreme Court).

Professor Weiner is an elected member of the American Law Institute. She also is a member of the International Society of Family Law. She currently serves on the Executive Committee of the Family Law Section of the American Association of Law Schools. She is also President of the Order of the Coif, a national honorary society that recognizes excellent student and faculty achievement.

# BARATANG CONSTANCE MOCUMIE



Justice Baratang Constance Mocumie is a Justice of the Supreme Court of Appeal, since 2016. She acquired her legal qualifications between 1987 and 2005: Baccalareus Juris/Bachelor of Jurisprudence (B. Juris), Legume Baccalaureus /Bachelor of Laws (LLB) and Legum Magister/Master of Laws (LLM) Specialising in Family Law from various universities: University of Zululand, University of the North West and University of South Africa respectively. She is registered for her LLD in Private International Law with the University of South Africa, 2023.

She was appointed a Magistrate in 1994. A Judge of the High Court in 2005. An Acting President of the Free High Court in 2015. She acted in the Labour Appeal Court, Competition Appeal Court and the Supreme Court of Appeal until her permanent appointment to the Supreme Court of Appeal in July 2016. Currently, she is the Acting Deputy President of the Supreme Court of Appeal.

In 2015, Justice Mocumie was nominated by the Chief Justice of the Republic of South Africa (the Republic) as Primary Liaison Judge on the Hague Conference to represent the judiciary of South Africa on International Network of Judges on the Hague Conference on Private International Law to make submissions on behalf of the judiciary. She is a member of the expert group on Cross Border Family Law Agreements.

Her role as a Network Judge is to facilitate direct judicial communication by serving as a link between her colleagues at domestic level and other members of the Network at international level. She also serves as a resource for her judicial colleagues domestically. She reports to the Chief Justice on the activities of the National Network of Judges on their work in their respective Divisions of the high courts on the number of applications they have received and finalised annually under the Hague Convention on Child Abduction.

Her commitment to family law has seen her regularly attend international conferences of Hague Convention Network Judges presented by the Hague Convention, such as

the Personal Responsibility under the 1996 Child Protection Convention, the 25th Anniversary of the HCCH 1996 Child Protection Convention and the Convention on International Child Abduction. She has presented on the International Child Abduction to the International Bar Association (IBA), Miami.

She has presented courses to Aspirant Judges, Newly Appointed Judges and Permanent Judges of the Superior Courts of South Africa, the Pan African Bar Association of South Africa (PABASA), and the International Academy of Family Lawyers (IAFL) since 2019 to date on the Hague Convention on Child Abduction and its practical application.

She has written numerous cases on the Hague Convention on Child Abduction both in the High Court and in the Supreme Court of Appeal of South Africa where she has shared her expertise on the Hague Convention, on Child Abduction,1980.One of her outstanding contribution is in LD v Central Authority (RSA) and Another (803/2020) [2022] ZASCA 6; [2022] 1 All SA 658 (SCA);2022 (3) SA 96 (SCA) (18 January 2022).

### **AAGJE IEVEN**



Aagje leven is Secretary General at Missing Children Europe, where she is responsible for the strategic development and day-to-day management of the organization. Aagje has a background in Health (Bachelor, KULeuven (BE) 1998), Political Philosophy (Master, KULeuven (BE) and Radboud University of Nijmegen (NL), 2002) and Law (Doctoral Programme Certificate, KULeuven (BE) and Columbia University New York (US), 2014). She has close to twenty years of experience in research and policy analysis on children's rights in Europe and has worked for a number of EU civil society organisations advocating for the rights and wellbeing of children and their families. She coordinated a campaign for the rights of children in alternative care and managed a European membership network supporting families affected by mental health issues. At Missing Children Europe she promotes research based advocacy, stakeholder engagement, prevention and quality service delivery. She developed the organisation's programmes on children who run away and on grooming and set up several research projects to improve the data available on missing children. Aagje is Missing Children Europe's focal point on parental abductions, a trained and certified family mediator and a guest lecturer in international family mediation at Thomas More University of Applied Sciences in Belgium.

### STEPHEN COBB



Lord Justice Stephen Cobb is a Court of Appeal Judge (England & Wales).

He was appointed to the High Court Bench in January 2013, and was assigned to the Family Division. He also sat as a Judge of the Court of Protection and in the Administrative Court

In June 2024 he was appointed as a Lord Justice of Appeal and he took up his place in the Court of Appeal in July 2025.

He has delivered judgments across the spectrum of family law issues and the Court of Protection.

He was the Family Division Liaison Judge for the North-Eastern Circuit from 2015-2021. He spent two years (2021-2023) as the Lead Reform Judge, supporting the judiciary at all levels in the Courts (in all jurisdictions) and Tribunals through HMCTS' digitisation programme.

During his judicial career, he has also chaired the President's Private Law Working Group (2014-2021); he has been a member of the Ministry of Justice 'Voice of the Child' Working Group, and in 2019-2020 was the judicial member of the Ministry of Justice (MoJ) 'Harm Panel'. He is currently the Chair of the Cross-Jurisdictional Judicial Advisory Panel on Access to Justice within the MoJ's Overarching Reform Evaluation (2020-date). He is a 'Nominated Judge' of the Judicial Conduct Investigations Office.

He is a Consultant Editor of the Family Law Reports, and Family Law Journal, and has written and lectured on family law and Court of Protection issues in the UK and abroad, most recently in South Africa [June 2024], Washington DC [April 2025].

Before his appointment to the Bench, he was Chair of the Family Law Bar Association (2010-2011), Head of Chambers (1 Garden Court) (2007-2013), and one of the founder members of the Family Justice Council (2004-2010).

He is a graduate of the University of Liverpool (LLB Hons) (1984) and has received an Honorary Doctorate (LLD h.c.) from the University (2019).

# WILLIAM ALSTERGREN



# Chief Justice William Alstergren AO

The Honourable Chief Justice William Alstergren AO is the Chief Justice of the Federal Circuit and Family Court of Australia (Division 1) and the Chief Judge of the Federal Circuit and Family Court of Australia (Division 2).

His Honour was appointed as Chief Judge of the Federal Circuit Court of Australia and a Justice of the Family Court of Australia on 13 October 2017. On 15 December 2017, his Honour was appointed Deputy Chief Justice and on 10 December 2018 his Honour was appointed Chief Justice of the Family Court of Australia.

On 1 September 2021 the Courts were renamed the Federal Circuit and Family Court of Australia (Division 1) and (Division 2) respectively. His Honour was also previously the administrative head of the Appeal Division of the Court.

After graduating from Melbourne University in Law (and completing an LLM), Chief Justice Alstergren undertook articles with Kenna Croxford & Co. From 1991 he practised as a barrister in Melbourne and took silk in 2012. His Honour was regularly briefed in large and complex commercial, family, industrial, administrative law and tax trials and appeals in the Federal Court, Family Court and state superior courts.

His Honour is a former Chairman of the Victorian Bar. Immediately prior to coming to the Bench, His Honour was the President of the Australian Bar Association.

He was appointed an Officer of the Order of Australia in 2022 in recognition of his eminent service to the law, judiciary and sport.

His Honour is the Head of Jurisdiction for two national courts which include 126 judges, 150 registrars and 700 staff in 17 permanent locations and over 30 regional locations across Australia.

## SESSION 2

#### LAURA MARTINEZ-MORA



Laura Martínez-Mora is First Secretary (Lawyer) at the Permanent Bureau of the HCCH and co-head of Family & Child Protection Law Division. In particular she is responsible for the post-Convention services in relation to the 1993 Adoption Convention as well as the Parentage / Surrogacy legislative project. She is also involved in the work related to the 1980 Child Abduction Convention and the 1996 Child Protection Convention. Such work includes post-Convention services (e.g. meetings of Special Commissions to review the practical operation of the above Conventions, Experts' Groups and Working Groups, seminars and workshops; drafting good practice guides, questionnaires, fact sheets and other documents) and legal advice, capacity building and training of professionals in different countries in Africa, the Americas, Asia and Europe (in particular through the Intercountry Adoption Technical Assistance Programme).

Prior to joining the HCCH, Laura worked for the International Social Service in Switzerland, UNICEF in Chile, the European Commission and the Council of Europe. She received her law degree from the University of Valencia (Spain), a Master of Laws (LL.M) in International Law with a specialisation in child's rights and comparative family law from the University of London (UK), and a Diploma in Child Protection and Juvenile Justice from the University Diego Portales in Santiago (Chile).

### JEFFERY MOREHOUSE



Jeffery Morehouse is the Executive Director and a co-founder of <u>Bring Abducted Children Home</u> and a founding partner of <u>The Coalition To End International Parental Child Abduction</u>.

His experience of seeking the return of his son "Mochi" Atomu Imoto Morehouse, who was kidnapped to Japan by his ex-wife in 2010, inspired him to become an advocate for other families facing similar challenges.

Over the past 15 years he has testified multiple times before the U.S. Congress, state legislatures and the United Nations on the crisis of international parental child abduction (IPCA). In multiple U.S. courts, he has been recognized as an expert witness in prevention cases. Working closely with government officials and organizations, he continues to raise awareness and push for stronger laws and policies to prevent future abductions and reunite families with existing ones.

His efforts have been featured in numerous media outlets, including *The Asahi Shimbun, Asia Times, The Sydney Morning Herald, The Toronto Star, The Washington Post, and The Washington Times.* 

Mr. Morehouse is a co-author and co-editor of two U.S. Department of Justice publications, "When Your Child is Missing: A Family Survival Guide, Fifth Edition" and the forthcoming "A Family Resource Guide on International Parental Kidnapping, Third Edition."

# ANNELIES HENDRIKS



Dr. Annelies Hendriks, is a developmental psychologist/MfN-registered mediator, working also as a cross-border mediator affiliated with the International Child Abduction Center and as a guardian ad litem in child abduction cases, appointed by the courts and tribunals of appeal. As a mediator, she handles many complex contact/access and childcare arrangements and assists parents in drafting a parenting plan, naturally listening to the children. As a cross-border mediator, Annelies collaborates with a team of mediators specializing in child abduction cases. These mediators are coordinated by the Mediation Bureau. affiliated with the International Child Abduction Center (www.kinderontvoering.org/mediation). Annelies can also be appointed by the court as a guardian ad litem in IKO cases to bring forth the voice of the child in the procedures. She teaches various courses for organizations and is a lecturer, providing training to judges on parent-child issues, among other things. She also gives an annual guest lecture at Vrije Universiteit Amsterdam on international child abduction. She also provides peer supervision for VFAS lawyer mediators and guardians ad litem.

### **NOELLE HUNTER**



Dr. Noelle Hunter is a clinical assistant professor of political science at the University of Alabama in Huntsville (UAH) and director of the International Child Abduction Prevention and Research Office (ICAPRO). She is an associate with the National Criminal Justice Training Center (NCJTC) at Fox Valley Technical College, where she contributes to national efforts on child protection and family justice. Dr. Hunter is the principal investigator for *Mapping the Journey*, a longitudinal study examining the lived experiences of youth survivors of international parental child abduction.

She has testified before the U.S. Congress multiple times on enforcement of the Sean and David Goldman International Child Abduction Prevention and Return Act and presented her survivor-focused research internationally. She served as president and co-founder of iStand Parent Network Inc. from 2014 - 2023, and is a founding partner of the Coalition to End International Parental Child Abduction. Her recent article, Between Protection and Parental Rights: The Hague Abduction Convention, Domestic Violence Allegations, and Article 13(1)(b), appears in the Athens Journal of Law (Vol. 11, Issue 4, 2025).

### MAAYIMUNA N'DIAYE



Maayimuna N'Diaye is a young adult survivor of International Parental Child Abduction (IPCA), and a graduating senior at Bob Jones High School in Madison, Alabama. She will attend the University of Alabama in Huntsville, where she plans to continue her advocacy and research on child abduction and youth resilience.

Maayimuna serves as a co-investigator on *Mapping the Journey: A Study of Perceptions and Lived Experiences Among Youth Affected by International Parental Child Abduction*, a research project exploring the voices and reunification journeys of abducted youth. A Girl Scouts USA ambassador and youth ambassador for iSTAND Survivor Network, Maayimuna is also a certified peer listener through the Born This Way Foundation, an initiative that builds mental health literacy and equips young advocates with tools to support peers in crisis. She has extensively covered court cases related to International Child Abduction. She is also an expert on Strategic Litigationat the European Court of Human Rights. In November 2020, she was appointed to the European Commission's Expert Group on Migration, Integration and Asylum. She has more than 24 years of experience in Advocacy, Policy-Making and International Strategic Cooperation with Civil Society Organisations.

JOHN GOMEZ



John Gomez is from New York City. He graduated with a bachelor's degree in physical sciences from Harvard University and a master's degree from John F Kennedy University in interdisciplinary consciousness studies. He has lived in Japan since January 1995. He has worked on the parental child abduction issue involving children taken within or to Japan since 2008. This includes working on the issue in Washington, DC appealing to the US Department of State and US Congress. In 2013, Kizuna Child-Parent Reunion was established as an NGO registered in Tokyo. He is a founding Director and has served as Chairperson since its inception. The mission of Kizuna Child-Parent Reunion is to protect the human rights of children and their right to access both parents. With several parents and officials, they brought Japan to ratify and implement the 1980 Hague Convention on the Civil Aspects of International Child Abduction. Two talks were given to the EU Delegation to Japan. He attended the United Nations Convention on the Rights of the Child review of Japan in Geneva. He has listened to hundreds of parents involved in parental child abduction cases. Kizuna has appeared in the news in at least nine languages.

### **ALISON SHALABY**



Alison Shalaby OBE is the Chief Executive Officer, reunite International Child Abduction Centre

Alison has been instrumental in the development of the charity reunite since 1991, initially as a volunteer member of reunite's Management Committee and now as Chief Executive Officer.

Under Alison's leadership, reunite operates a 24-hour telephone advice line managing in excess of 17,000 calls per annum, and offers cross-border mediation and advocacy to more than 1,500 families every year. Alison has developed longer-term preventative initiatives, including urging changes to UK legislation, raising awareness about child abduction, research into the impact of child abduction, pressing foreign governments to deal more effectively with the problem, and using international fora to promote mediated solutions. Reunite's exemplary global reputation has enhanced the UK's reputation in dealing with this distressing issue. Many parents consider reunite's support has been crucial in helping them cope with the distress of this devastating situation and reuniting them with their children.

Alison's dedication to this cause stems from personal experience; her own daughter was abducted to Egypt as a child and only returned after a difficult struggle.

Alison is also a trained mediator, specialising in cross-border children's cases.

### LIINA NAABER-KIVISOO



Liina Naaber-Kivisoo is judge and the President of the Harju County Court in Estonia. She is specialized to cases involving children (custody questions, access rights and child abduction). Before becoming a judge, she used to be an attorney and she worked a short period in the European Commission´s legal service.

JHOSEP Y. LOPEZ



Justice Jhosep Y. Lopez was appointed to the Supreme Court as its 190th Associate Justice on January 25, 2021.

A dedicated academic, Justice Lopez graduated *cum laude* with a degree in Political Science from University of the Philippines (UP) in 1984, followed by his law degree in 1988. He was admitted to the Philippine Bar in 1989.

Justice Lopez has built a distinguished legal and public service career. He began as **Legal Counsel** of the University of the Philippines and later served as **Chief Legal Officer** of the UP Manila-Philippine General Hospital. He went on to become **Chief Legal Counsel of the Senate** under the leadership of then Senate President **Jovito Salonga.** Justice Lopez also represented the City of Manila's Third District as a City Councilor for four terms.

Notably, Justice Lopez formerly held key national positions: he was the Chief Legal Consultant of then Health Secretary Felipe Estrella, until he was appointed as the Philippines' first agriculture attaché to Beijing, China. In 2001, he returned to serve as City Councilor for Manila until his appointment as City Prosecutor. His journey in the judiciary began when he was appointed as an Associate Justice in the Court of Appeals in 2012, serving in that capacity for nine years.

An academician at heart, Justice Lopez made significant contributions to the academe as a professor in several universities, such as the UP College of Law, New Era University, and the *Pamantasan ng Lungsod ng Maynila*. Apart from his advocacy in education and learning, he champions the cause of Filipino families and children as the co-chairperson of the Supreme Court Committee on Family Courts and Juvenile Concerns (CFCJC)—a role that reflects his enduring commitment to justice and public service.
