# Convention Recouvrement des aliments et Protocole Obligations alimentaires de 2007 : Rapport du Groupe de travail sur la coopération administrative

## I. Aperçu

- 1 Lors de sa réunion de 2021, le CAGP a adopté la Conclusion et Décision suivante :

« Le CAGP s'est réjoui des travaux accomplis par le Groupe de travail sur la coopération administrative et par le Groupe de travail sur la loi applicable. Le CAGP a enjoint au BP de prendre les dispositions nécessaires pour organiser une nouvelle réunion du Groupe de travail sur la coopération administrative en amont de la réunion de la Commission spéciale. »
- 2 Sur cette base, le Groupe de travail sur la coopération administrative (Groupe) concernant la *Convention du 23 novembre 2007 sur le recouvrement international des aliments destinés aux enfants et à d'autres membres de la famille* (Convention Recouvrement des aliments de 2007) s'est réuni le 10 mai 2021 afin de poursuivre ses travaux<sup>1</sup>. Cette réunion a conduit à la rédaction du Doc. pré. No 16<sup>2</sup>.
- 3 En octobre et novembre 2021, un sous-Groupe de travail s'est réuni en vue d'aider le Groupe à se concentrer sur « la définition claire des éléments de données »<sup>3</sup>.
- 4 Enfin, le Groupe s'est réuni en décembre 2021<sup>4</sup> en vue de finaliser le Doc. pré. No 18A<sup>5</sup>. Le Groupe s'est accordé sur deux rapports statistiques dans le cadre de la Convention Recouvrement des aliments de 2007 : un « rapport standard » et un « rapport facultatif / volontaire »<sup>6</sup>. Un résumé de l'ensemble des travaux menés par le BP avec l'aide du Groupe figure dans le Doc. pré. No 18A.
