Dr João Ribeiro-Bidaoui is First Secretary and Diplomat Lawyer at the Permanent Bureau of the HCCH, heading the Transnational Litigation Team. He has primary responsibility over the Working Group on Jurisdiction, the 2005 Choice of Court and 2019 Judgments Conventions, the Principles on Choice of Law, the Tourists and Visitors (ODR) Project, as well as the 1965 Service, 1970 Evidence, and 1980 Access to Justice Conventions. He had charge over the final phases of the Judgments Project, which resulted in the adoption, at the Twenty-Second HCCH Diplomatic Session, of the 2019 Judgments Convention. Previously, Dr Ribeiro-Bidaoui was Head of the UNCITRAL Regional Centre for Asia and the Pacific and served as Director of International Affairs of the Ministry of Justice of Portugal. He also served as Deputy Secretary General of the Conferences of Ministers of Justice of the Iberian-American countries (COMJIB) and of the Portuguese Speaking countries (CMJPLOP). He holds a bachelor's degree and a masters in law from the University of Coimbra (Portugal), a masters in International Relations from the University of Cambridge (United Kingdom), and a doctoral degree from the NOVA University of Lisbon (Portugal).

Winston Anderson. The Hon. Mr Justice Winston Anderson, of Jamaican origin and upbringing, took the degree of Bachelor of Law from the University of the West Indies in 1983, and in 1988 graduated with a Doctorate in Philosophy from Cambridge University. Also, in 1988 he was called to the Bar of England and Wales and later to the Bar of Barbados and Jamaica. He was Professor of Law at UWI where he taught for 22 years, Executive Director of the Caribbean Law Institute Centre, and General Counsel of the Caribbean Community. Professor Anderson was elevated to the Bench of the Caribbean Court of Justice (CCJ) in 2010 and became the founding Chairman of the CCJ Academy for Law. Justice Anderson is a member of several global organizations related primarily to International Law, Environment, and Sport. He is also author of numerous articles in referred journals and of several leading texts. As Chairman of the Academy he conceptualized the 'Eminent Caribbean Jurists Awards' in 2019 of which Pioneering Caribbean Women Jurists 2021 is the second edition.



Fabienne Schaller is a Judge in the international commercial chamber of the Paris court of appeal (ICCP-CA). She was admitted to the Paris Bar in 1986 and to the New York Bar in 1992. She graduated with a master of law from Paris X-Nanterre Law School and a LL.M in trade regulation from NYU Law School. After practicing as a lawyer in Paris and New York, she joined the Bench in 1997. Between 2008 and 2014, she worked at the Ministry of Justice and participated in the negotiations of EU directives and international conventions within the Counsel of Europe in Strasbourg. She was appointed in 2014 as vice-president in the criminal division of the Paris Court. As an appeal Judge in the Paris Court of appeal since 2016 and in the international commercial chamber created in 2018, she specializes in international commercial disputes relating to contracts, transport, actions for damages, and international arbitration.

Trevor Carmichael. Sir Trevor Carmichael was born in Barbados and educated at Harrison College and the University of the West Indies, Mona, Jamaica. A member of the Middle Temple in London, he was called to the Barbados Bar in December 1977. His original practice areas spanned criminal, constitutional, labour, divorce, trademarks and later he has focused on commercial, charities and environmental law. He is associated with landmark legal decisions including the leading case on medical insanity which he presented before the Barbados Court of Appeal in 1981.

A member of the International Bar Association, as well as an associate member of the Canadian Bar Association, the International Tax Planning Association, the International Fiscal Association, he was one of the parties responsible for establishing a Barbados Chapter of the International Fiscal Association of which he is Charter President.

He is also a Certified International Arbitrator with the International Museums Association (ICOM).
