Introduction

The objective of the Fourth meeting of the Special Commission is to review the practical operation of the *Hague Convention of 29 May 1993 on Protection of Children and Co-operation in Respect of Intercountry Adoption* ("1993 Hague Convention"). The discussion on the first day (8 June 2015) on "20 years of the 1993 Hague Convention" will not, however, follow the usual format of a Special Commission review as it will include presentations by some experts and some "round table" sessions to introduce certain topics. There will be a period for discussion after the presentations and round table sessions, aiming to find common ground in responding to the issues raised.

<u>Please note</u>: The agenda will be treated with some flexibility during the Special Commission meeting and may be further modified in light of discussions. In order to make best use of the available time, the agenda does not contain a comprehensive list of issues arising under the 1993 Hague Convention, but attempts to draw attention to those items needing most discussion.

Timing of the sessions

It is proposed that the sessions will last from 9.00~a.m. to 1.00~p.m. and 2.30 to 6.00~p.m., with lunch breaks from 1.00 to 2.30~pm and breaks for coffee / tea from 11.00 to 11.15~a.m. and from 4.00 to 4.15~p.m.

Note on procedures

Delegations to the Special Commission may, before or during the course of the meeting, wish to submit for circulation short written proposals, comments or documents containing information relevant to the proceedings. This may be done by providing the Permanent Bureau with a proposal (in electronic format, typed or clearly written) as a Working Document or Information Note in English or French (preferably both). Translations into Spanish are also welcome. The documents should clearly indicate which delegations are associated with the proposal / document. The Permanent Bureau staff will set up the documents in a standard format and distribute them as a Working Document or Information Note, depending on the nature of the proposal / document. The Permanent Bureau is unfortunately not in a position to provide translation of such documents into English, French or Spanish.

An advisory group will be established at an early stage during the Special Commission to assist in preparing the draft Conclusions and Recommendations, to be considered for adoption on the last day of the meeting. It is expected that this group will meet on Tuesday evening, Thursday evening and, if needed, on Friday during the lunch break.
