

I. Introduction

- 1. At its March 2019 meeting, the Council on General Affairs and Policy (CGAP) "mandated the Permanent Bureau to start preparations for a possible first meeting of the Special Commission to review the practical operation of the 2007 Convention and 2007 Protocol by circulating questionnaires on those two instruments by July 2019. The Permanent Bureau will report on the outcomes of those questionnaires to Council [CGAP] at its meeting in 2020. Based on this report, Council [CGAP] will consider whether there is a need for a first meeting of the Special Commission, possibly to be held in June 2020."
- 2. Two questionnaires were circulated in August 2019.² By 27 October 2020, 32 Members³ had responded to the Questionnaire on the 2007 Child Support Convention and 18 Members⁴ had responded to the Questionnaire on the 2007 Maintenance Obligations Protocol. This corresponds to a response-rate of 37.64% and 21.17% respectively.
- 3. That said, the responses received, as briefly summarised below, show an interest and a need to hold a first meeting of the Special Commission (SC) to review the practical operation of the 2007 Convention and the 2007 Protocol.
- 4. At its March 2020 meeting, "CGAP mandated the PB to continue the preparations for the first meeting of the SC on the practical operation of the 2007 Child Support Convention and its Protocol. CGAP invited the PB to make arrangements for a meeting of a Working Group prior to the SC to discuss applicable law issues. The findings of the Working Group will inform the work of the SC." ⁵ Furthermore, "[n]oting the low number of responses to the questionnaires circulated in preparation for the SC, CGAP decided to extend the deadline for responses until 17 April 2020". ⁶ Finally, "CGAP decided to postpone the first meeting of the SC tentatively scheduled for June 2020 and invited the PB to make arrangements for a meeting before the end of 2020". ⁷
- 5. On 18 March 2020, the PB informed National Organs and Central Authorities designated under the 2007 Child Support Convention, that arrangements were made for the First Meeting of the SC take place during the week of 14 to 18 December 2020.⁸ It was decided then that the exact dates of the meeting will be confirmed as soon as possible, as well as the dates for the meeting of the Working Group to discuss applicable law issues. The meeting dates and arrangements would be re-assed at the end of the third quarter in the light of the evolving coronavirus (COVID-19) situation.
- 6. On 6 October 2020,⁹ after writing to Members on 28 July 2020¹⁰ regarding the preparations for the First Meeting of the SC, and after having received feedback from Members on the various scenarios proposed, the PB informed Member / Contracting Parties that the SC meeting previously scheduled

for December 2020 will be postponed until the week of 7 to 11 June 2021. The PB took this decision in the light of recent developments relating to the COVID-19 pandemic, which unfortunately do not allow for an in-person meeting in The Hague in the coming months. The precise timing and format of the SC meeting will be discussed and decided at the CGAP 2021 meeting, which is scheduled to take place during the week of 1 to 5 March 2021.

7. Prior to the rescheduled SC, the PB will hold videoconference meetings of the Administrative Cooperation Working Group (ACWG) to discuss statistics under the 2007 Convention and other administrative cooperation matters such as recommended forms and country profiles (scheduled from 14 to 18 December 2020) and the Applicable Law Working Group (ALWG) (scheduled for 22 and from 25 to 27 January 2021). Furthermore, the Experts' Group on international transfer of maintenance funds (EGITMF) will meet by videoconference from 8 to 11 February 2021. For all three meetings, sessions will take place in the afternoon Central European Time.¹¹

II. Analysis of the responses received

8. In general, responses to both Questionnaires are to the effect that the 2007 Child Support Convention and 2007 Maintenance Obligations Protocol both operate well without any major problems. This being said, a few operational issues could be improved with the assistance of discussions taking place at a first meeting of the SC. Furthermore, Members have indicated an interest for the development of additional tools and additional forms under the Convention.

A. Analysis of the responses received in relation to the 2007 Convention

- 1. Issues identified by States for discussion at the SC with a view to identify good practices or adopt conclusions and recommendations
- Response time with regard to acknowledgement of receipt of applications (Annex II of the 2007 Convention) or no response at all
- Use of the Status of Application Reports
- Acceptance of an abstract of a decision in place of a complete text of a decision
- Contracting Parties making available mandatory and recommended forms in the required languages other than English and French (Art. 44)
- Applications made in the name of a creditor child (including therein the name and date of birth of the custodial parent)
- Applications from creditors studying abroad (i.e., interpretation of "residence")
- Transfer of cases within States with non-unified legal systems (e.g., federal States)
- Issues surrounding Central Authorities acting as public bodies (e.g., entitlement to legal assistance in the requested State)
- Issues concerning the establishment of parentage
- Issues concerning the interpretation / application of Article 22 (e)
- Issues concerning the interpretation / application of Article 56
- Enforcement of child support arrears after the child has reached the age of 21 years
- Issues concerning the interruption / suspension of enforcement of child support for creditors under the age of 18 years
- Issues concerning the recognition and enforcement of maintenance obligations for relationships not provided by the law of the requested State
- Currency conversion issues (discussion to take place in the context of the report of the Experts' Group on international transfers of maintenance funds)

More information and documents, including agendas and Microsoft Teams' videoconferencing instructions, will follow in due course.

- Difficulties encountered to locate respondents
- Difficulties encountered by certain States to obtain relevant information concerning the income and, if necessary, other financial circumstances of the debtor or creditor, including the location of assets, the national minimum wage and the annual rate of inflation in each Contracting Party
- Difficulties encountered in enforcing decisions that set the amount of child support in a percentage of the income of the debtor
- Difficulties encountered to enforce a decision against assets when the debtor's habitual residence is not the State where the enforcement is to take place
- Requirement under the domestic law of certain States that applications be signed when filed with competent authorities
- Difficulties encountered by the requested State to certify an applicant via telephone or to verify the authenticity of the signature of the applicant
- Missing Country Profiles and Country Profiles out of date (including notification as to when Country Profiles are updated)
- Wish to obtain regular up-dates of the HCCH website

2. Discussion of additional tools and forms

9. Responses to the Questionnaire on the 2007 Child Support Convention show a high interest for the development of guidance for the completion of Mandatory and Recommended Forms, a high interest for the development of a Guide to Good Practice for Central Authorities, a strong-medium interest for the development of a standardised statistical report for Central Authorities and a weak-medium interest for the development of an extension of the current Country Profile to cover spousal support. Profile to cover spousal support Responses to the Questionnaire also show an interest to discuss the development of additional forms and dynamic mandatory and recommended forms. In light of the relatively low number of responses received, the responses are not necessarily representative of the positions of all Members but are certainly representative of the position of the 41 States bound by the 2007 Child Support Convention.

B. Analysis of the responses received in relation to the 2007 Protocol

10. Responses to the Questionnaire on the 2007 Protocol show that a very small number of States would like to discuss issues surrounding "habitual residence". Two States would like to know from other Contracting Parties whether Article 4(3) had an impact on the number of applications for modifications based on the law of the debtor (forum). One State has identified the issue of access to foreign law as a possible subject of discussion as well as which law applies to the preliminary question of parentage and which law governs the requirements for the possibility to request the modification of a decision. The same State has indicated an interest to discuss the issue of "closer connection" under Article 5. Finally, that same State would like to discuss the coordination between the 2007 Protocol and the Conventions of 1956 and 1973 on the Law Applicable to Maintenance Obligations.

III. Next step – Holding a first meeting of the SC

A. Draft agenda and time allocation

- 11. Current plans are for a three-day meeting of the SC to take place during the week of 7 to 11 June 2021. The meeting will assist States (Parties and non-Parties) to get a better understanding of the practical operation and indeed relevance of the 2007 Convention and its Protocol. It is suggested to devote two and a half days to discussions on the 2007 Convention which would include operational issues (as described above), international transfer of maintenance funds, iSupport and the development of additional tools and forms. The discussions concerning the development of additional tools will be assisted with the development of documents prepared and circulated in advance of the meeting for comments (see the list of documents below) and a December 2020 meeting of the ACWG (see above). The discussion of future forms will take place in the light of responses found in Annexes II and III, the priorities identified therein and a preliminary discussion of the subject by the ACWG. Discussions on the 2007 Protocol in the form of a Working Group will take place online on 22 and from 25 to 27 January 2021; the ALWG will report to the SC (see above). A half-day would be devoted to the adoption of Conclusions and Recommendations. A draft agenda will be circulated by the end of the first quarter of 2020.
- 12. A half-day information session prior to the meeting of the Special Commission could be organised by the PB.¹⁷ Additionally, arrangements could be made to allow States to meet on a bilateral basis prior to the meeting of the Special Commission.¹⁸


