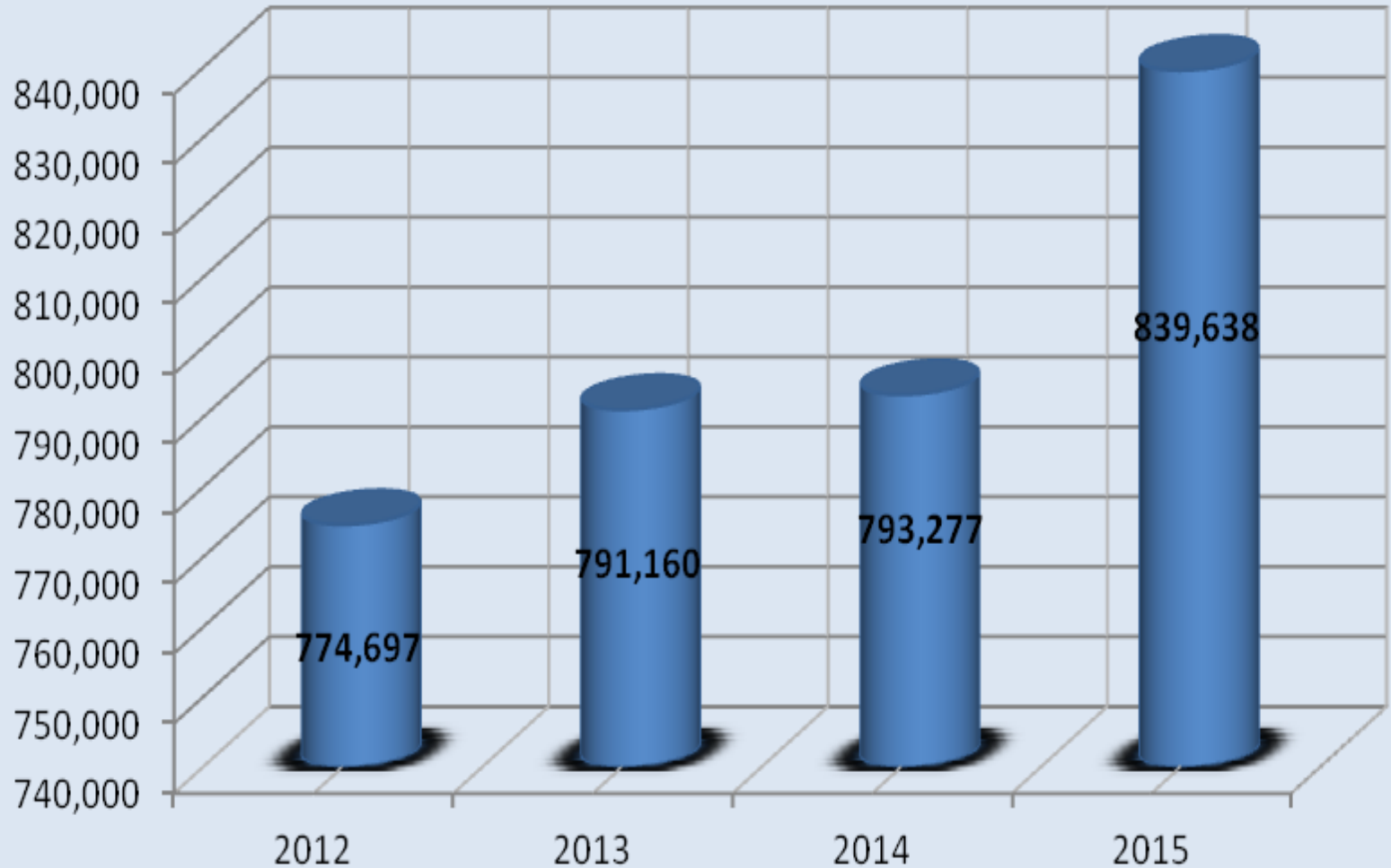

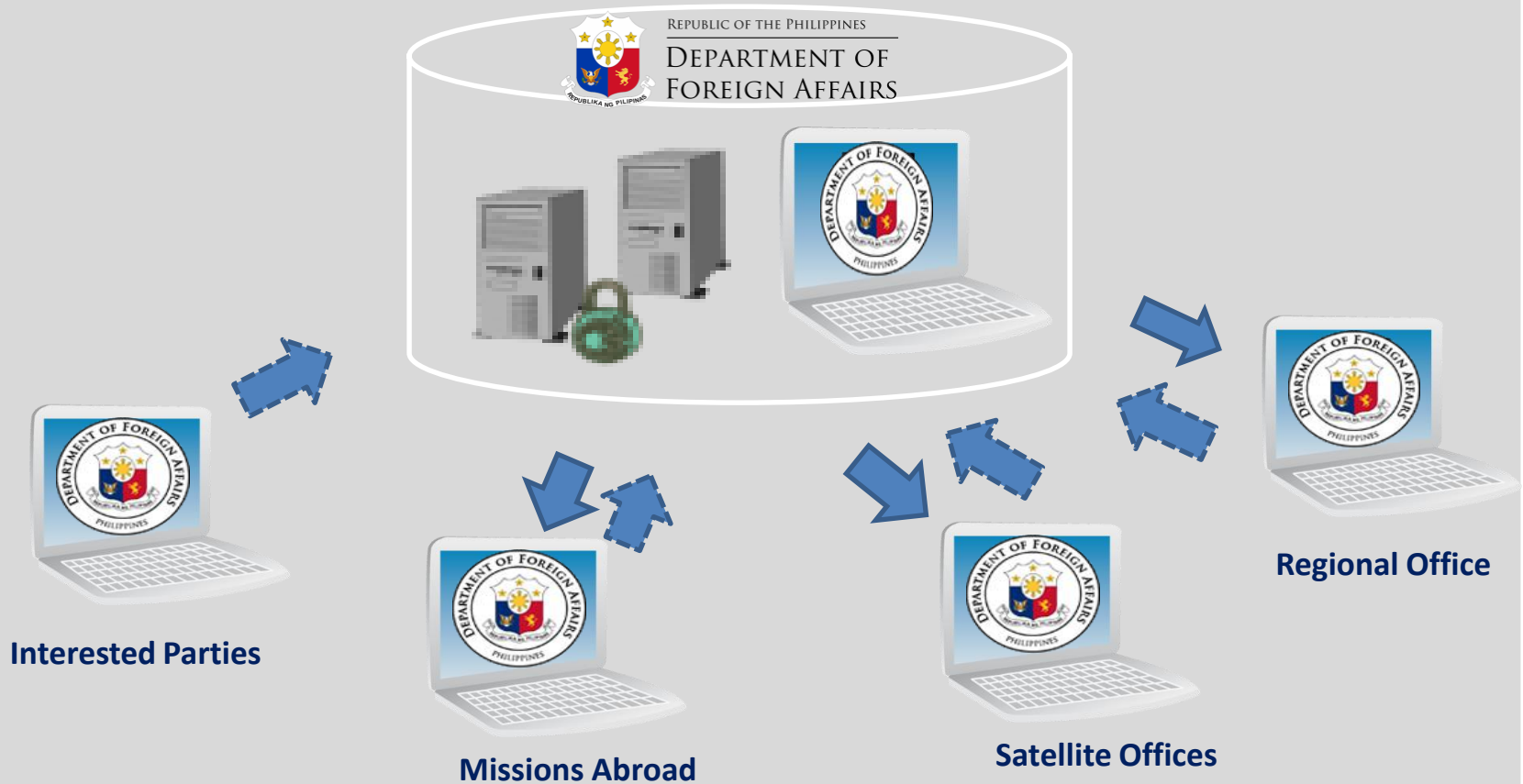

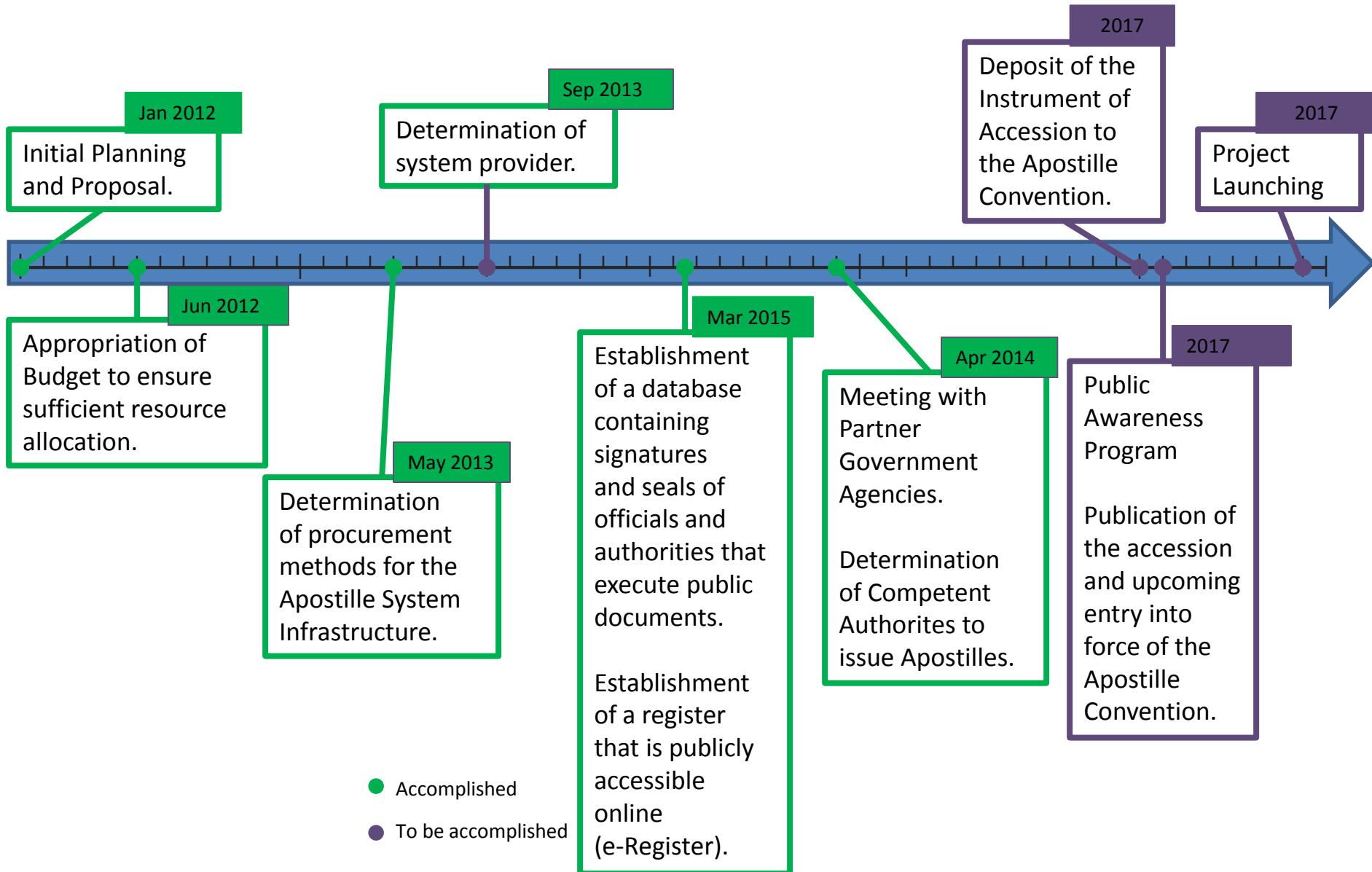


ISO 9001 Certification
