	During the COVID-19 pandemic, unless with exemption, all non-Hong Kong residents coming from overseas countries and regions by plane will be denied entry to HKSAR. As such, Eexemption was specially applied and granted to allow entry of the prospective overseas adoptive parents who were non-Hong Kong residents to HKSAR for matching and escorting the child to the Receiving States for commencement of adoption placement. Up till March 2021, there were five children involved in such situation.
