Dr Margaretha Sudhof

State Secretary at the Federal Ministry of Justice and Consumer Protection, Germany

Dr Margaretha Sudhof is a former judge at Frankfurt am Main Administrative Court and has been State Secretary at the Federal Ministry of Justice and Consumer Protection since July 2019. Before joining the Ministry, she was State Secretary at the Berlin Senate Department for Finance (2012–2019). She has previously held the positions of Permanent Deputy to the Director-General for Crisis Management and Civil Protection at the Federal Ministry of the Interior (2010–2012) and Deputy Director-General for Interior and Legal Policy at the Federal Chancellery.



Dr Christophe Bernasconi

Christophe Bernasconi has been Secretary General of the HCCH since 2013. He has long-standing expertise in the fields of international civil procedural law, international commercial and finance law, and international family and child protection law. He also serves as a judge at the Higher Regional Court in Karlsruhe, Germany, with a special responsibility for the recognition and enforcement of foreign titles and arbitral awards. From 2009 to 2012 he has held a chair of Civil Law, Private International Law and Comparative Law at Europa-Universität Viadrina Frankfurt (Oder), Germany. He has been appointed as a member of the Council of the International Association of Procedural Law (IAPL) and as a Fellow of the European Law Institute. His main research interests lie in the fields of cross-border dispute resolution, comparative law, conflict of laws, and European private law.

Colleen McMahon

Chief Judge, U.S. District Court, Southern District New York, United States of America

Colleen McMahon has been appointed to the United States District Court for the Southern District of New York by President William J. Clinton in 1998. She received her undergraduate education at The Ohio State University (B.A.) and her legal education at Harvard Law School (J.D.). After a few years in private practice at Paul, Weiss, Rifkind, Wharton & Garrison, Judge McMahon served as a Speechwriter and Special Assistant to the Honorable Donald McHenry, United States Mission to the United Nations. She then returned to Paul, Weiss, where in 1984 she became the first woman litigator to be elected as a partner of that firm. Judge McMahon served as a Judge of the New York Court of Claims (1995) and as an Acting Justice of the Supreme Court of the New York Supreme Court (1995–1998).



Dr Marcelo De Nardi

Federal Judge, Federal Court of First Instance of Rio Grande do Sul, Brazil

Dr Marcelo De Nardi has been a judge at the Federal Court of First Instance of Rio Grande do Sul, Brazil since 1993. Currently he is presiding the Environmental, Land and Indigenous Peoples Issues Federal Court of Porto Alegre, Rio Grande do Sul, the southernmost State of Brazil. He holds a PhD in Law from the Universidade Federal do Rio Grande do Sul – UFRGS, Brazil and is Professor of International Trade Law and Private International Law at the Universidade do Vale do Rio dos Sinos – UNISINOS, LL.M. and graduate programs in Brazil. Dr Marcelo De Nardi has been invited lecturer to various Universities and other institutions, including the HCCH and the WIPO. He also serves as expert advisor for different institutions, including the Brazilian Delegation to the Experts Group on the Jurisdiction Project of the HCCH.



Haerang Lee

Noëlle Lenoir

She was the first woman and the youngest Justice ever to have served on the French Constitutional Court (1992–2001). Beforehand she served as Justice on the Conseil d'Etat (French Supreme Court on administrative matters). As French Minister for Europe (2002–2004). Ms. Lenoir has taught at Columbia Law School, University College London and several French universities. She is Honoris Causa of UCL and Suffolk University.



Willem Visser

Court Registrar & Senior Law Clerk, Netherlands Commercial Court – Utrecht District Court, the Netherlands

Mr Visser studied Private Law at Utrecht University (the Netherlands) and obtained a MA in 1998. He worked as a Student Researcher for the Netherlands Institute of Human Rights. Since his graduation he has been in the employ of the Dutch Judiciary. First as a Senior Law Clerk assisting judges in drafting judgments in complex civil cases, in particular in the area of private international law. In 2019, he became the Registrar and Administrator of the Netherlands Commercial Court. In this capacity, he oversees the general operations of the court. He was appointed member of several national judicial expert groups, including the Expert Group on European Private Law which he continues to serve. She attended a Law and Logic Summer Course of the European University Institute (Florence).



Michael Baylson

Judge, U.S. District Court, Eastern District of Pennsylvania, United States of America

Michael M. Baylson was appointed to the U.S. District Court for the Eastern District of Pennsylvania by President George W. Bush and took office in July 2002. He graduated from the Wharton School of Finance & Commerce (B.S. Econ.) and the Law School (LL.B.) of the University of Pennsylvania. Before Judge Baylson joined Duane Morris and became a partner in 1974, he served as an Assistant District Attorney, as Chief of the Homicide Division. He handled complex civil litigation matters and tried numerous cases, specializing in class actions, antitrust and securities issues. Judge Baylson served as a member of the Advisory Committee on Civil Rules of the Judicial Conference of the United States from 2005–2010. He currently serves on the Third Circuit Committee on Model Criminal Jury Instructions. He is an Adjunct Professor at the University of Pennsylvania Law School, where he leads a seminar in Commercial Litigation Strategy.



Elizabeth Zorrilla
